PENALTY FOR NON COMPLIANCE



Clause from the 2021 EPR regulations regarding penalties for non compliance:

Penalties.-

- (1) A person convicted of an offence under these Regulations is liable to-
- (a) imprisonment for a period not exceeding 15 years;
- (b) an appropriate fine; or
- (c) both a fine and imprisonment.
- (2) A registered producer who does not comply with these Regulations may have their registration as contemplated in these Regulations revoked and/or be compelled to join another extended producer responsibility scheme.
- (3) A registered producer responsibility organisation that does not comply with the requirements as contemplated in these Regulations may have their registration revoked.

ENTERPRISE DEVELOPMENT

WASTE PICKER INTEGRATION

Polyco provides support to waste pickers to improve their working environment (ablution facilities), hygiene packs and PPE. Polyco's weigh pay app can also pay waste picker a service fee. Currently investigating payment through collection partners.



ENTERPRISE DEVELOPMENT TRAINING PROGRAMS

Polyco is empowering **70 young individuals** through a six-month **business training program**, fostering entrepreneurship and sustainable waste management. Additionally, funded training for 13 enterprises at the ISWA Conference, supported 2 enterprises at the SAPRO Awards and provided bursary support. A Packa-Ching workshop also engaged 27 enterprises to enhance collaboration and industry impact.
